

(15) Description of equipment:

The F110-Exc is an intrinsically safe rugged tablet for use in explosive hazardous areas of zone 2 and zone 22.

The device can be used with accessories Shoulder-Strap, Hand-Strap or Shoulder Harness Strap, 4 point strap, Capacitive Hard Tip Stylus & Tether and Digitizer Pen & Tether. The device can also be used with optional modules, such as Barcode reader, FINGER PRINTER and RFID module.
